

Research Advisory Council Member – Academic (University affiliation) Role Description

The **Academic (university affiliation) member** is a key voting position on WeRPN's 12-member Research Advisory Council (RAC) which oversees WeRPN's research program and provides guidance to achieve the WeRPN research mandate. Specifically, the role of the Research Advisory Council member — Academic (University affiliation) is to provide advice on WeRPN's strategic research direction, research priorities, annual work plan, processes, and policies, based on university research experience and collaborative network connections.

The **WeRPN** research mandate is to equip the association with jurisdictional and category specific RPN-focused evidence that will guide health system decisions, nursing research excellence, and knowledge mobilization to be used to:

- o build upon and expand the current RPN research evidence,
- o initiate and pursue meaningful health system and workforce policy changes, and
- o implement novel and innovative nursing practice/intervention protocols, and collaborative interprofessional models of care.

Terms of Commitment

The voluntary 2-year term voting position is commensurate with July 1 of the fiscal year. Attendance is required at quarterly meetings. Some exceptions apply.

Time Requirements (estimated)

- Virtual Meetings: 1 hour, 4 times per year
- Annual General Meeting: 2 hours, once per year
- Participation in RAC activities: 1-research day, 7 hours, once per year plus travel (if applicable)

Duties of Research Advisory Council members include:

- o Establishing relevant research topic areas/ideas,
- o Advising on how to capture WeRPN members' opinions, e.g., focus groups, survey, about essential research topics,
- o Ensuring research priorities are aligned with the strategic plan drivers of impact,
- o Prioritizing, recommending, and promoting RPN research priorities,
- o Approving priority areas and project description included in annual Call for proposals (academic research and fellowships grants)

- o Establishing a researcher network to support the identification of collaborative opportunities (e.g., Supporting Patient-Oriented Research (SPOR) Ontario SPOR Support unit (OSSU) and access to specific areas of expertise (e.g., research methods, data analysis),
- o Reviewing WeRPN Calls for Academic Research Proposals, fellowship applications, external participant recruitment requests, and research partnership requests,
- o Evaluating and recommending research and fellowship grant applications for funding,
- o Providing recommendations to the WeRPN Executive leadership regarding research initiatives,
- o Evaluating the nominations for the Awards of Excellence in research,
- o Establish and maintain a RPN literature database including a review, summary, and ranking of RPN-specific research publications,
- o Monitoring research expenditures and investments,
- o Evaluating the research strategy outcomes, and
- o Identifying and recommending new Research Advisory Council members, as necessary.
